Needs complete body work and fully painted and fully reassembled. Does come with the hardtop which was also an option for 1965. All body panels, glass and interior parts appear to be present - 1976 Chevrolet 350 built engine on stand. Engine block code was milled off and "Ken Gowdy" stamped on the engine pad. Engine appears to be completely rebuilt. Engine casting number 3970010, Engine casting date: F236 June 23, 1976 - Corvette rear end with half shafts and front yoke. Hoosier rears 30.0/9.0 R15 and Goodyear fronts 28.0X4.5-15. Note: Car and parts identification was done by a third party. New replacement parts list came from the estate's records.
